## Results for America Statement on Passage of Bipartisan Evidence-Based Policymaking Commission Act

RFA Praises Bipartisan Lawmakers for Promoting Evidence-Based Policymaking

**WASHINGTON** – Results for America CEO and Co-founder Michele Jolin issued the following statement today after the U.S. House of Representatives passed the final version of S.991, the Evidence-Based Policymaking Commission Act. This legislation would provide policymakers with more information and access to data so that government can make better decisions about what programs are really working for young people, families, and communities. The bill was sponsored by U.S. House Speaker Paul Ryan (R-WI) and U.S. Senator Patty Murray (D-WA). The U.S. Senate passed S. 991 unanimously on March 16, 2016.

"Results for America applauds and supports the passage of the Evidence-Based Policymaking Commission Act. This bill would create a Commission to provide recommendations to make data more open, transparent, and accessible so that both the public and private sectors can improve government services and produce better results for all Americans. The bipartisan support for the bill reflects the growing consensus across the country for investing taxpayer dollars in what works. We call this a Moneyball approach to governing because policymakers are using data, evidence, and evaluation to make more informed decisions to improve the lives of young people, their families, and communities."

## Specifically, the bill would—

- Establish a "Commission on Evidence-Based Policymaking" charged with reviewing the inventory, infrastructure, and protocols related to data from federal programs and tax expenditures, while developing recommendations for increasing the availability and use of this data;
- Require the Commission to evaluate the merits of and provide guidance for creating a "clearinghouse" for program and survey data. The clearinghouse would make available and facilitate the merging of data sets that are valuable in evaluating program effectiveness and informing domestic policymaking;
- Require several agencies to provide assistance to the Commission including the Office of Management and Budget, Census, and the U.S. Departments of Health and Human Services, Education, and Justice; and
- Require the Commission to study how best to protect the privacy rights of people

who interact with federal agencies and ensure confidentiality.

The Obama administration also has expressed support for the Commission. The administration's FY17 <u>budget request</u> included \$10 million to improve the work of the Census Bureau, which would include creating a commission focused on realizing the potential of administrative data.
